

**Somerset County Council
(Various Roads, Taunton, Taunton Deane)
(Temporary Traffic Restrictions) (Special Events) Order 2019
(Cricket World Cup 2019)**

The County of Somerset in exercise of their powers under Section 14 of the Road Traffic Regulation Act 1984, as amended and after giving notice to the Chief Officer of Police, hereby makes the following order:

1. This Order will come into effect on the 30th day of May 2019 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. The Order shall come into operation at 1900 hours on Friday the 7th of June 2019 and will remain in force until 2000 hours on Monday the 17th of June 2019.
3. Save as provided in Article 4, 5 and 6 of this Order no person shall cause or permit any vehicle to proceed or wait in the lengths of road specified in the Schedules to this Order.
4. Nothing in Article 3 of this Order will apply to:
 - i. Anything done with the permission or at the direction of a police officer in uniform.
 - ii. Police, Fire and Ambulance emergency service vehicles.
 - iii. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
 - iv. any vehicle being used for the purpose of maintenance of the road and operations; maintenance of street furniture and infrastructure; supply of gas, water or electricity; agriculture on any land adjacent;
5. Exemptions are provided for as specified in the Schedules to this Order for Taxis, local buses, event vehicles and access and egress to the Castle Hotel.
6. Exemption have been provided for access and egress for deliveries between the hours of 0600 and 0900 for all roads specified in Schedule 1
7. This Order may be cited as Somerset County Council (Various Roads, Taunton, Taunton Deane) (Temporary Traffic Restrictions) (Special Events) Order 2019 (Cricket World Cup 2019).

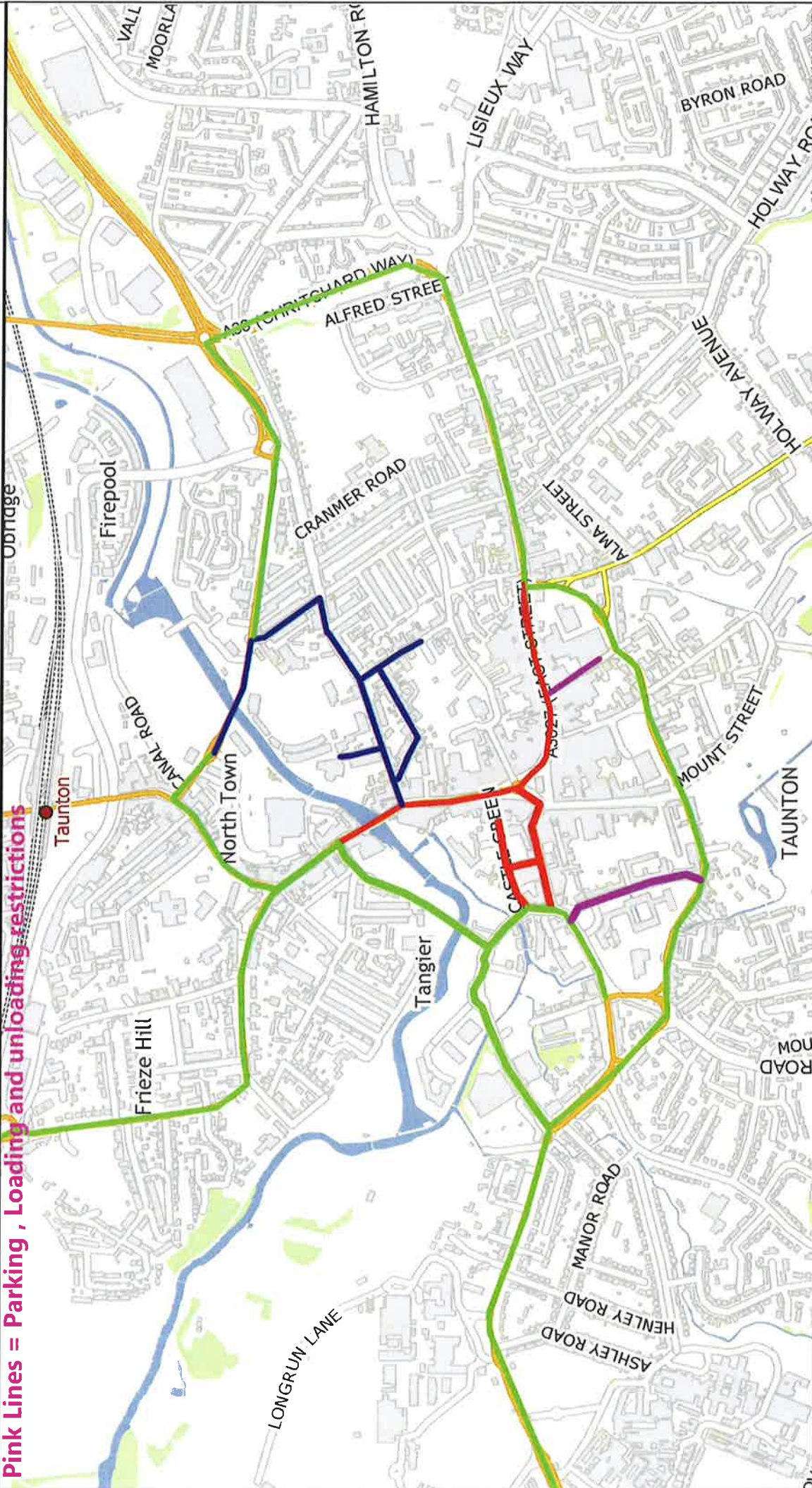
