Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order: -

This Order will come into operation on the 2nd day of July 2019 and will remain in force for sixty months. The effect of which will be to introduce a temporary prohibition of vehicles in the layby specified in the schedule to this Order. The restrictions will only apply when indicated by traffic signs.

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order:

- This Order will come into operation on the 2nd day of July 2019 and will remain in force for sixty months. The restrictions will apply when indicated by traffic signs.
- Except as provided in Article 3 of this Order no person will cause or permit any vehicle to enter, proceed or wait along the layby specified in the schedule to this Order.
- Nothing in Article 2 of this Order will apply to:
 - (i) Anything done with the permission or at the direction of a police officer in uniform;
 - (ii) Police, Fire and Ambulance emergency service vehicles.
 - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
 - (iv) Vehicles involved in agriculture or timber operations to access the layby.
- This Order may be cited as Somerset County Council, C1182 Layby off Combwich Road, Cannington (in the Parish of Otterhampton) (Temporary prohibition of vehicles) Order 2019.
