(Frome Half Marathon)**

Somerset County Council in exercise of its powers under Section 16 of the Road Traffic Regulation Act 1984, as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order: -

The Order will be made to facilitate the Frome Half Marathon and is in the interest of public safety. All closures will be signed and staffed and will remain in force only for as long as is necessary.

The Order shall come into operation at 0930 hours on Sunday 21<sup>st</sup> July 2019 and will continue in force until 1300 hours on Sunday 21<sup>st</sup> July 2019.

Exemptions are provided in the Order for emergency vehicles, residents requiring access and egress and any vehicles associated with the event.

The County of Somerset in exercise of their powers under Section 16 of the Road Traffic Regulation Act 1984, as amended and after giving notice to the Chief Officer of Police, hereby makes the following order:

1. This Order will come into operation on the 11<sup>th</sup> day of July 2019 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 3 of this Order no person will cause or permit any vehicle to enter, proceed or wait along the lengths of road specified in schedules to this Order
3. Nothing in Article 2 of this Order will apply to:
  - i. Anything done with the permission or at the direction of a police officer in uniform.
  - ii. Police, Fire and Ambulance emergency service vehicles.
  - iii. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
  - iv. any vehicle being used for the purpose of maintenance of the road and operations; maintenance of street furniture and infrastructure; supply of gas, water or electricity; agriculture on any land adjacent;

This Order may be cited as Somerset County Council, (Various Roads, Yeovil) (Temporary Prohibition of Vehicles) (Special Events) Order 2019 (Yeovil Half Marathon)
