1. This Order shall come into force on the xxxth day of xxxxxxxx 2019 and may be cited as the “Somerset County Council (A371 Wells Road, Shepton Mallet) (Parish of Shepton Mallet) (20mph Speed Limit) Order 2019”.

3. No person shall drive any motor vehicle at a speed exceeding 20mph on the length of road specified in the Schedule to this Order.
