ORDER 2019

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

1. This Order shall come into force on the 29th day of August 2019 and may be cited as "Somerset County Council (Various Roads, Barton St David) (Parish of Barton St David) (Revocation and 30mph Speed Limit) Order 2019".
2. The provisions of any other Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
3. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 2 to this Order.
4. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

Main Street to Silver Street, Barton St David	for its entire length
Church Street, Barton St David	for its entire length
Church Close, Barton St David	for its entire length
Broadclose Way, Barton St David	for its entire length
High Lane, Barton St David	for its entire length
Fairview Close, Barton St David	for its entire length
Peacocks Hill, Barton St David	for its entire length
Blind Lane, Barton St David	for its entire length
Barton Road, Barton St David	from the junctions with Peacocks Hill and Blind Lane in a southerly direction for a distance of 400 metres
Park Close, Barton St David	for its entire length
Mill Road, Barton St David	from its junction with High Lane for a distance of 540 metres in a north east and easterly direction to a point 210 metres west of its junction with Plot Gate

Laurels Drive, Barton St David	for its entire length
Park Lane, Barton St David	for its entire length
Silver Street, Barton St David	from its junction with Main Street to Silver Street for a distance of 68 metres in a north westerly direction
