

**Somerset County Council
(Various Roads, Bridgwater)
(Temporary Traffic Restrictions)

Notice is hereby given that Somerset County Council intends to make an Order in pursuance of Section 14 of the Road Traffic Regulation Act 1984 as amended, the effect of which will be to introduce the following temporary traffic restrictions in Bridgwater as detailed in the Schedules to the Order:

The Order will be made to facilitate the Bridgwater Fair 2019 and is in the interest of public safety. The restriction shall apply when indicated by traffic signs.

The Order shall come into operation at 0900 hours on Tuesday the 24th September 2019 and will continue in force until 1000 hours on Sunday the 29th September 2019.

Somerset County Council in exercise of their powers under Section 14 of the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers hereby makes the following Order.

1. The Order shall come into operation at 0900 hours on Tuesday the 24th September 2019 and will continue in force until 1000 hours on Sunday the 29th September 2019
2. No person shall cause or permit any vehicle to enter, proceed or wait along the lengths of road specified in Schedule 1 to this Order.
3. No person shall except upon the direction or with the permission of a Police Constable in uniform or a Parking Attendant employed by the Local Authority, cause or permit any vehicle to wait on the sides of road or in the lengths of road specified in Schedule 2 to this Order.
4. The 3 Tonne Weight Limit is temporarily revoked on the length of roads specified in schedule 3 to this Order.
5. Nothing in Article 2 or 3 of this Order shall apply to any vehicle being used for police, fire brigade or ambulance purposes; by businesses or delivery vehicles requiring access; or by vehicles associated with the event or by Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
6. This Order may be cited as "Somerset County Council (Various Roads, Bridgwater) (Temporary Traffic Restrictions) (Bridgwater Fair) Order 2019".
