

**Somerset County Council
(Various Roads, Taunton)
(Temporary Prohibition of Vehicles) (Special Events) Order 2019
(Taunton Deane 10K Road Races)**

The County of Somerset in exercise of their powers under Section 16 of the Road Traffic Regulation Act 1984, as amended and after giving notice to the Chief Officer of Police, hereby makes the following order:

1. This Order will come into operation on the 26th day of September 2019 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 3 of this Order no person will cause or permit any vehicle to enter, proceed or wait along the lengths of road specified in schedules to this Order
3. Nothing in Article 2 of this Order will apply to:
 - i. Anything done with the permission or at the direction of a police officer in uniform.
 - ii. Police, Fire and Ambulance emergency service vehicles.
 - iii. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
 - iv. any vehicle being used for the purpose of maintenance of the road and operations; maintenance of street furniture and infrastructure; supply of gas, water or electricity; agriculture on any land adjacent;

This Order may be cited as Somerset County Council, (Various Roads, Taunton) (Temporary Prohibition of Vehicles) (Special Events) Order 2019 (Taunton 10k Road Races)

Part 1

Temporary Prohibition of Vehicles Between the Hours of 1045 and 1115 On Sunday 29th September 2019 and Sunday 27th September 2020

Blackbrook Way Taunton	From its junction with Lisieux Way Roundabout to its junction with Ilminster Road Roundabout (its entire length)
Ilminster Road Taunton	From its junction with Ilminster Road Roundabout to its junction with Hamilton Road (its entire length)
Hamilton Road Taunton	From its junction with Ilminster Road to its junction with Wordsworth Drive (its entire length)
Wordsworth Drive Taunton	From its junction with Hamilton Road to its junction with Lisieux Way a distance of 170 metres in an easterly direction
Lisieux Way Taunton	From its junction with Wordsworth Drive to its junction with Lisieux Way Roundabout (its entire length)
Chestnut Drive Taunton	From its junction with Lisieux Way Roundabout to its junction with Upper Holway Road 380 metres in a south easterly direction.

Part 2

Temporary Prohibition of Vehicles between the hours of 1115 and 1200 on Sunday 29th September 2019 and Sunday 27th September 2020

Upper Holway Road, Taunton	From its junction with Chestnut Drive to its junction with Holway Road (its entire length)
Holway Road, Taunton	From its junction with Upper Holway Road to its junction with Holway Avenue (its entire length)
Holway Ave Taunton	From its junction with Holway Road to its junction with B3170 South Road (its entire length)
B3170 South Road Taunton	From its junction with Holway Road to its junction with Stoke Road a distance 700 metres.
Stoke Road, Taunton	From its junction with B3170 South Road to its junction with Chestnut Drive a distance 430 metres.
Stoke Road Stoke St Mary	From its junction with Chestnut Drive to its junction with Haydon Lane a distance of 4400 metres.

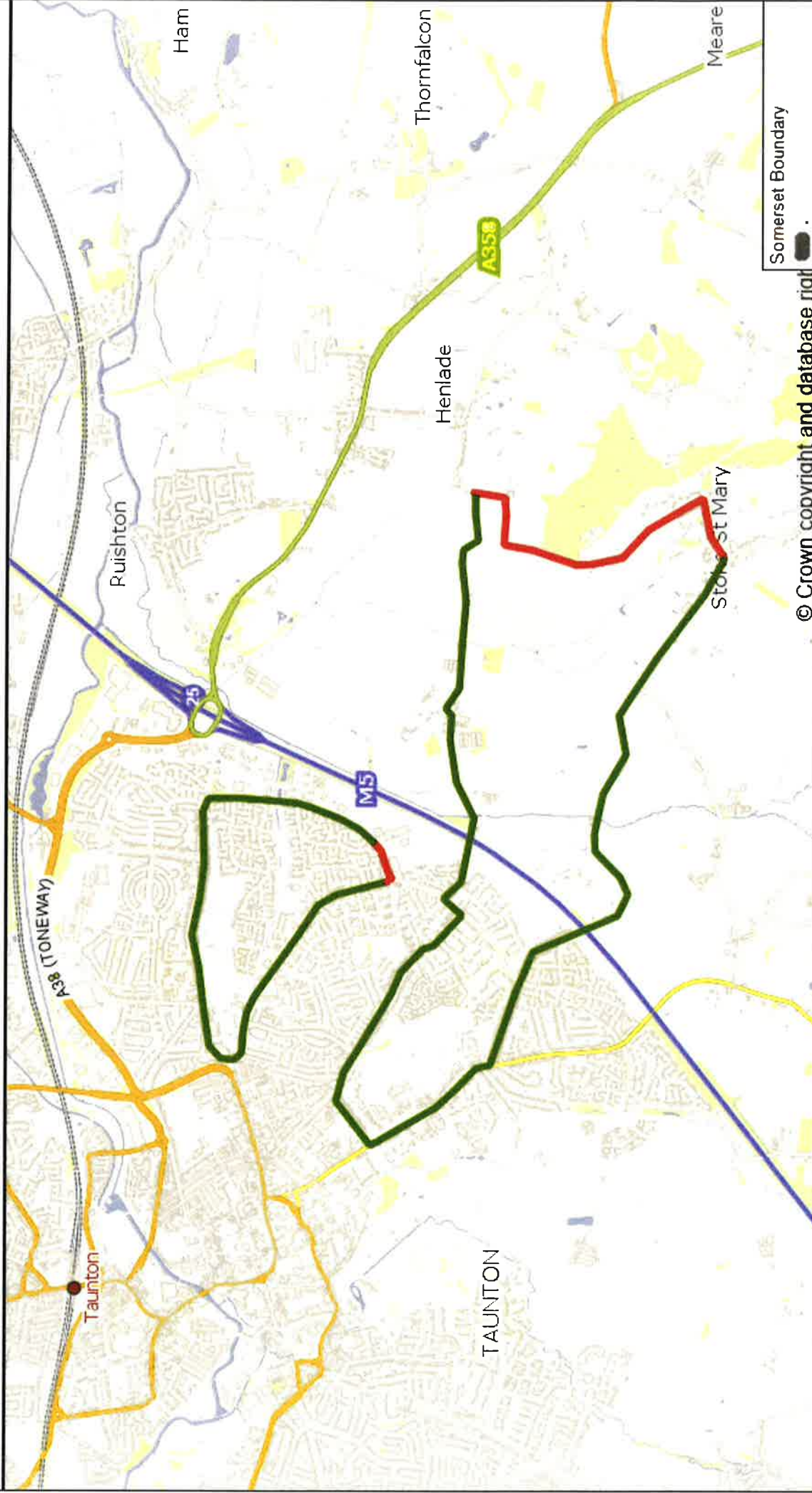
