

SOMERSET COUNTY COUNCIL
(JURSTON LANE, WELLINGTON)
(PARISH OF WELLINGTON)
(PROHIBITION OF MOTOR VEHICLES) ORDER 2019

The County Council of Somerset in exercise of its powers under Sections 1(1), 2(1) to (3) and 4(1) of the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. SAVE AS IN Article 2 of this Order, no person shall cause any motor vehicle to enter, proceed or wait in Jurston Lane, Wellington as shown in the Schedule below.

2. NOTHING in Article 1 of this Order shall apply so as to

a) prevent any person from causing any motor vehicle to proceed in the length of road referred to that Article if the vehicle is being used in connection with any building operation or demolition in or adjacent to that road, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred, or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer, or of any main pipe or apparatus for the supply of gas, water or electricity or of any apparatus as defined in Paragraph 1 (1) of the Telecommunication Code contained in Schedule 2 to the Telecommunications Act, 1984.

b) the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in the service of a local authority, the Environment Agency, a water undertaker or sewerage undertaker in pursuance of certain statutory powers or duties.

c) vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

This Order shall come into operation on the 31st October 2019 and may be cited as "Somerset County Council (Jurston Lane, Wellington) (Parish of Wellington) (Prohibition of Motor Vehicles) Order 2019".

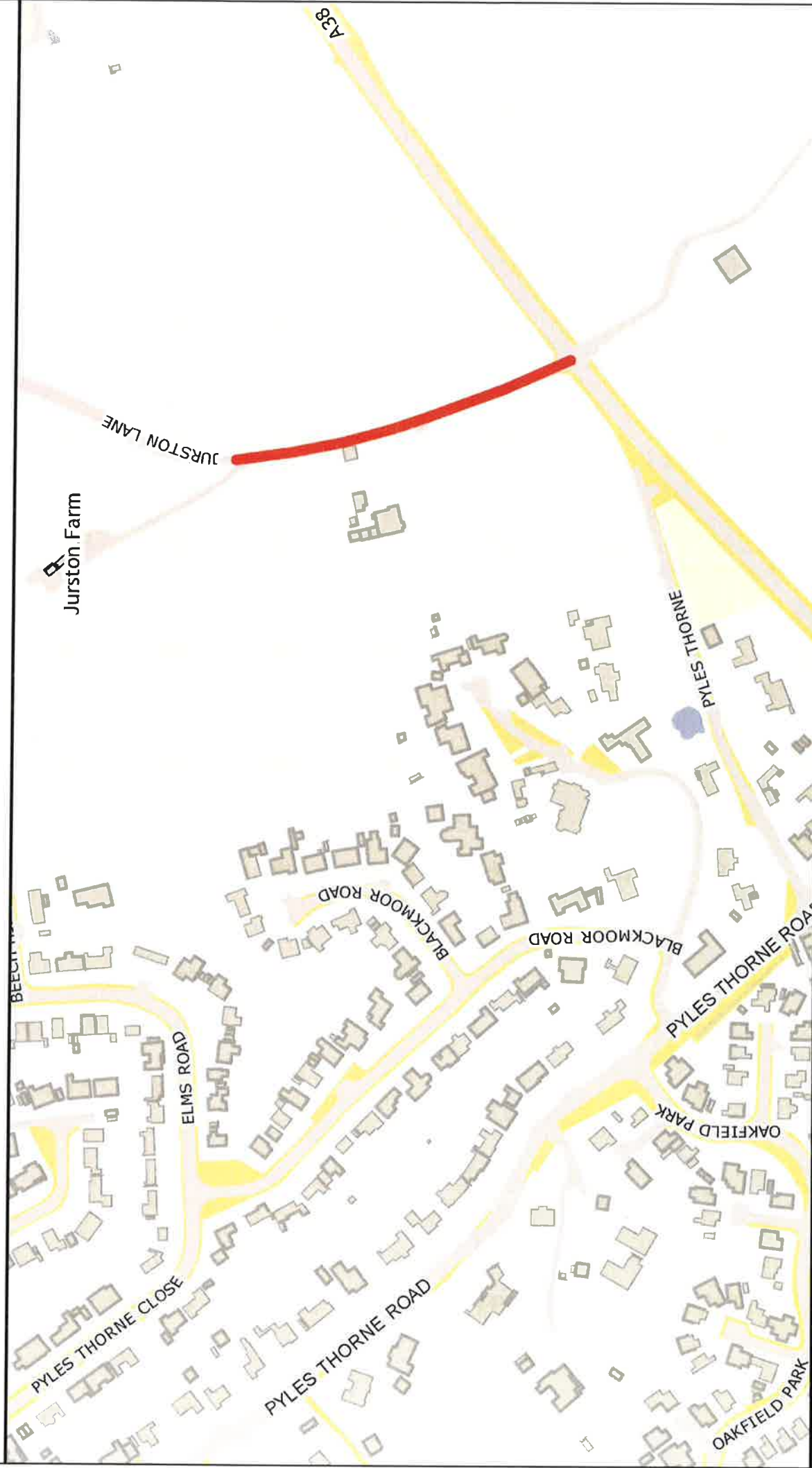
Jurston Lane, Wellington
