RUSSET ROAD, SOMERTON
(PROHIBITION OF MOTOR VEHICLES)
EXPERIMENTAL ORDER 2019

NOTICE is hereby given that on 25th October 2019 Somerset County Council made an Experimental Order in exercise of its powers under Sections 1, 2, 4, 9 and 10, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The effect of this Order is to prohibit the driving of motor vehicles on Russet Road, Somerton as specified in Schedule 1 to this Notice. The Order shall come into force on 4th November 2019 and will remain in force for a maximum period of 18 months.

Full details of the scheme are contained in the experimental order. SCHEDULE 1

Prohibition of Motor Vehicles

Russet Road, Somerton at a point approximately 10 metres north of its junction with Bancombe Road

STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The Council's reasons for proposing to make the above Order are as follows: -

Due to road safety concerns and traffic management issues expressed by residents, the Town Council and local County Councillor it is proposed to implement changes, the effect of which is to prohibit the driving of motor vehicles on Russet Road, Somerton, on an experimental basis. This will enable the Council to monitor the situation to determine whether the measures are effective and also to see what impact the scheme has on traffic in the area.

Once the monitoring process has been concluded a decision will be then taken by the County Council as to whether the provisions of the Order should continue in force indefinitely.
