

**SOMERSET COUNTY COUNCIL**  
**(VARIOUS ROADS, BRIDGWATER)**  
**(REVOCAION, 40MPH SPEED LIMIT AND 50MPH SPEED LIMIT)**  
**ORDER 2019**

SOMERSET COUNTY COUNCIL in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

1. This Order shall come into force on the 8th day of October 2019 and may be cited as the "Somerset County Council (Various Roads, Bridgwater) (Revocation, 40 mph Speed Limit and 50mph Speed Limit) Order 2019".
2. The provisions of any other Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
3. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule 1 to this Order.
4. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in the Schedule 2 to this Order.
5. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

**40 mph Speed Limit**

Bristol Road Roundabout by Ascot Drive, Bridgwater	For its entire length
Ascot Drive, Bridgwater	From Bristol Road Roundabout for a distance of 40 metres in an easterly direction
Ascot Drive, Bridgwater	From a point 40 metres east of Bristol Road Roundabout to its junction with Bristol Road Roundabout approaching in a westerly direction
A38, Bristol Road, Bridgwater (Northbound Carriageway)	From a point 213 metres south of the junction with Gerber Roundabout for a distance of 714 metres in a northerly direction.
A38, Bristol Road, Bridgwater (Southbound Carriageway)	From a point 166 metres north of the junction with Polden Business Park Approach for a distance of 1015 metres in a southerly direction
Gerber Roundabout, Bridgwater	For its entire length
Polden Business Park Approach, Bridgwater (both directions)	From the junction with the A38 Bristol Road for a distance of 23 metres in an easterly direction
Express Park Approach off Bristol Road, Bridgwater (both directions)	From the Gerber Roundabout in an westerly direction for a distance of 28 metres

A38 Dunball Roundabout	For its entire length
A39 Road from Interchange to Roundabout, Bridgwater	From Dunball Roundabout in an easterly direction for a distance of 36 metres
A39 Road from Interchange to Roundabout, Bridgwater	From a point 31 metres east of the junction with Dunball Industrial Estate road for a distance of 250 metres

A38 Bristol Road, Bridgwater	approaching Dunball Roundabout in a westerly direction
Dunball Mill Approach (eastbound carriageway and westbound carriageway)	From Dunball Roundabout in a northwest direction for a distance of 31 metres
Dunball Industrial Estate Road, Bridgwater	From Dunball Roundabout for a distance of 56 metres
Station Road, Bridgwater	From the junction with the A38 Bristol Road in an easterly direction for a distance of 19 metres
A38 Bristol Road, Bridgwater (Southbound Carriageway)	From the junction with A38 Bristol Road in an easterly direction for a distance of 81 metres
A38 Bristol Road, Bridgwater (Northbound Carriageway)	From the junction with the Dunball Roundabout in a southerly direction for a distance of 1342 metres
	From the junction with the Dunball Roundabout in a southerly direction for a distance of 1593 metres
