

Somerset County Council

(Minehead Christmas Festival)

Notice is hereby given that Somerset County Council intends to make an Order in pursuance of Section 16 of the Road Traffic Regulation Act 1984 as amended, the effect of which will be to introduce the following temporary traffic restrictions in Minehead as detailed in the Schedules to this Notice.

The Order will be made to facilitate the Minehead Christmas Festival and is in the interest of public safety. All closures will be signed and staffed and will remain in force only for as long as is necessary.

The Order shall come into operation on Friday 29th November 2019 from 00:01 hours until 05:30 hours on Monday 2nd December 2019.

Exemptions are provided in the Order for emergency vehicles, residents requiring access and egress and any vehicles associated with the event.

Exemptions are provided in the Order for Taxi drivers to park in temporary taxi ranks located in Bancks Street and Blenheim Road.

Statement of reasons for proposing to make the Order

Somerset County Council in exercise of their powers under Section 16 of the Road Traffic Regulation Act 1984, as amended and after giving notice to the Chief Officer of Police, hereby makes the following order:

1. This Order will come into operation on the 22nd day of November 2019 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 5 of this Order no person will cause or permit any vehicle to enter, proceed or wait along the lengths of road specified in Schedule 1 to this Order.
3. Except as provided in Article 5 of this Order no person will cause or permit any vehicle to enter, proceed or wait along the lengths of road specified in Schedules 2 and 4 to this Order.
4. No person shall except upon the direction or with the permission of a Police Constable in uniform or a Parking Attendant employed by the Local Authority, cause or permit any vehicle to wait on the sides of road or in the lengths of road specified in Schedule 3 to this Order.
5. Nothing in Articles 2, 3 and 4 of this Order will apply to:
 - i. Anything done with the permission or at the direction of a police officer in uniform.
 - ii. Police, Fire and Ambulance emergency service vehicles.
 - iii. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
 - iv. any vehicle being used for the purpose of maintenance of the road and operations; maintenance of street furniture and infrastructure; supply of gas, water or electricity; agriculture on any land adjacent and any vehicles associated with the event;
 - v. With reference to Schedule 2 any vehicles relating to Iceland or Best Friend Pet Suppliers to have access (against the one way system) and egress.
 - vi. With reference to Schedule 2 any vehicles requiring access against the

one way system) and egress.

vii. With reference to Schedule 4 any registered taxis picking up and dropping off passengers.

6. This Order may be cited as Somerset County Council, (Various Roads, Minehead) (Temporary Traffic Restrictions) Order 2019 (Minehead Christmas Festival)
