ORDER 2019

NOTICE is hereby given that Somerset County Council proposes to make the above Order in pursuance of the provisions of the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce a 20mph Speed Limit and a 30mph Speed Limit on the lengths of roads as specified in the Schedules below.

The provisions of any other Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.

A copy of the draft Order, the maps showing the lengths of roads affected and the Statement of Reasons for proposing to make the Order may be inspected at Somerset Highways, B Block Reception, County Hall, Taunton and online at www.somerset.gov.uk/TRO.

Persons wishing to object to the proposed Order may do so in writing, specifying the grounds on which it is made, to Somerset County Council, Traffic Management, B2 West, County Hall, Taunton, TA1 4DY, quoting Reference No. DR05112019 and received no later than 21 days from the publication of this notice.

The names and addresses of anyone writing in may be made available for public inspection and will be included in a report that may be published on the Somerset County Council website, unless the individuals concerned state, in writing, their objection to their names and addresses being made so available or being included in the publication.

Coles Lane	For its entire length
Knapp Hill	For its entire length
Hele Lane	For its entire length

Roundwell Street	For its entire length
Prigg Lane	For its entire length
Market Square	For its entire length
The Parade,	For its entire length
North Street	From its junction with St James Street, northwards for 30 metres
West Street	From its junction with Hele Street, south westwards to the junction with Bakers Court
Crown Lane	For its entire length
Summer Shard	For its entire length
Palmer Street	For its entire length
Careys Hollow	From its junction with Compton Road, south westwards for 130 metres
George Lane	For its entire length
Silver Street	From its junction with St James Street, to its junction with Prigg Lane

Compton Road	From its junction with Palmer Street, north westwards to the junction with West End View
West Street	From its junction with Summer Shard, to its junction with Bakers Court
