

Somerset County Council
Vicarage Walk, Middle Street and Bond Street, Yeovil
(Temporary prohibition of vehicles,
suspension of one-way system and parking restrictions) Order 2019

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following order:

1. This Order will come into operation on the 19th day of December 2019 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. The one-way system on Bond Street is temporarily revoked on the length of road specified in schedule 3 to this Order.
3. Except as provided in Article 3 of this Order no person will cause or permit any vehicle to enter, proceed or wait, loading and unloading along the lengths of road specified in schedules to this Order
4. Nothing in Article 2 and 3 of this Order will apply to:
 - (i) Anything done with the permission or at the direction of a police officer in uniform;
 - (ii) Police, Fire and Ambulance emergency service vehicles.
 - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
5. This Order may be cited as Somerset County Council Vicarage Walk, Middle Street and Bond Street, Yeovil (Temporary prohibition of vehicles, suspension of one-way system and parking restrictions) Order 2019

Temporary Prohibition of Vehicles

Vicarage Street, Yeovil	From its junction with Middle Street for its entire length.
Middle Street, Yeovil	From its junction with Stars Lane to its junction with Vicarage Street

Schedule 2
Temporary prohibition of waiting, loading and unloading

Bond Street, Yeovil	From its junction with South Street to its junction with Middle Street.
Middle Street, Yeovil	From its junction Bond Street to its junction with Vicarage Street

Schedule 3
Temporary Revocation of One-Way System

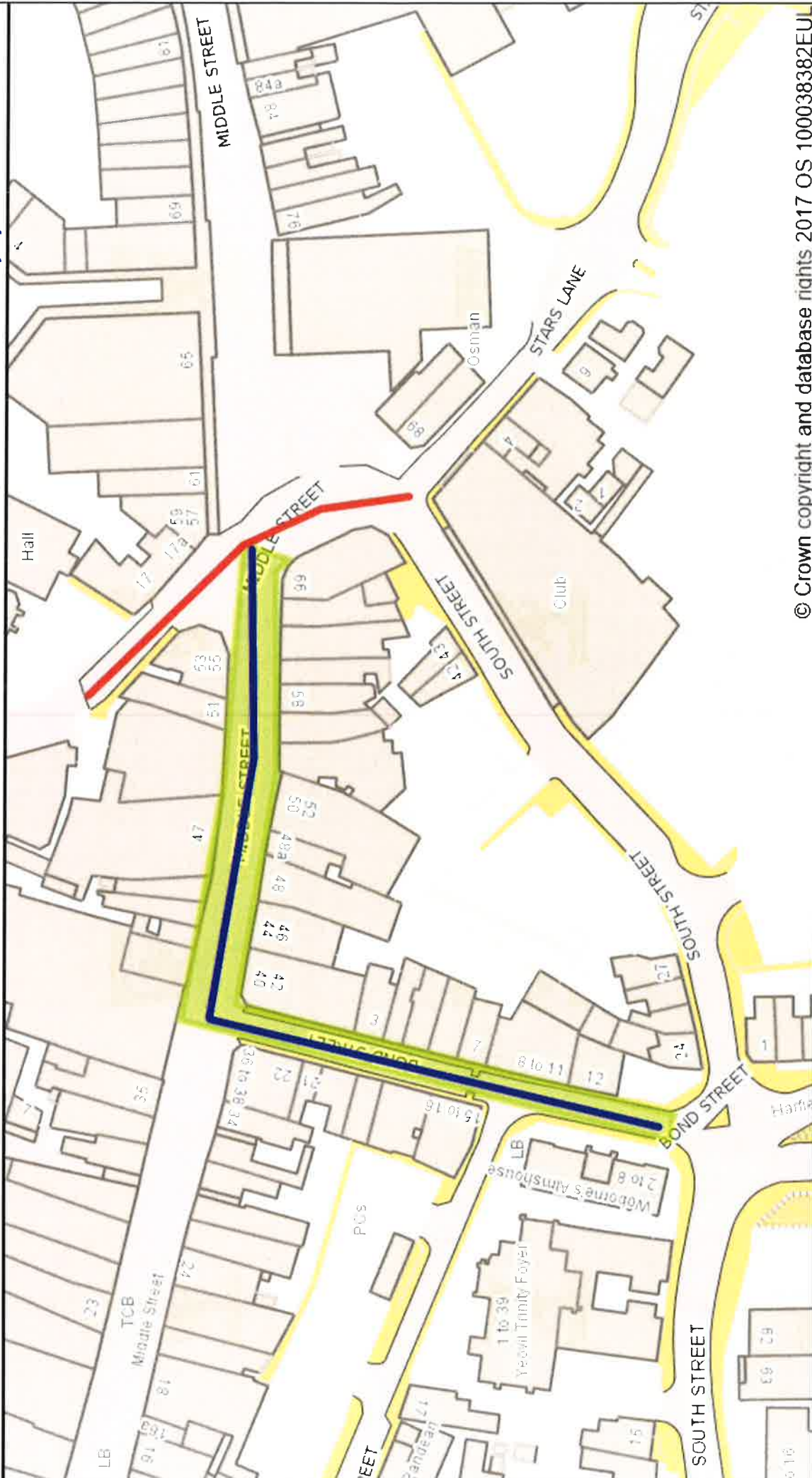
Bond Street, Yeovil	From its junction with South Street to its junction with Middle Street.
