Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order: -

This Order will come into operation on the 19<sup>th</sup> day of December 2019 and will remain in force for eighteen months. The effect of which will be to introduce a temporary prohibition of vehicles in the roads specified in schedule 1 to this Order, a temporary prohibition of waiting, loading and unloading on the roads specified in Schedule 2 to this Order and a temporary revocation of the one-way system on the roads specified in Schedule 3 to this Order.

The works are expected start on the 6<sup>th</sup> day of January 2020 and to last for 15 days, the restrictions will only apply when indicated by traffic signs.

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following order:

1. This Order will come into operation on the 19<sup>th</sup> day of December 2019 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. The one-way system on Bond Street is temporarily revoked on the length of road specified in schedule 3 to this Order.
3. Except as provided in Article 3 of this Order no person will cause or permit any vehicle to enter, proceed or wait, loading and unloading along the lengths of road specified in schedules to this Order
4. Nothing in Article 2 and 3 of this Order will apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform;
  - (ii) Police, Fire and Ambulance emergency service vehicles.
  - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.
5. This Order may be cited as Somerset County Council Vicarage Walk, Middle Street and Bond Street, Yeovil (Temporary prohibition of vehicles, suspension of one-way system and parking restrictions) Order 2019
