**(Temporary Prohibition of Motor Vehicles**  
**and Suspension of One-Way Restriction)**  
**Order 2019**

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order:

1. This Order will come into operation on the 2<sup>nd</sup> day of January 2020 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 3 of this Order no person will cause or permit any vehicle to enter, proceed or wait along the lengths of road specified in the schedules to this Order
3. The one way system is temporarily revoked on the length of road specified in Schedule 2 of this Order
4. Nothing in Article 2 of this Order will apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform;
  - (ii) Police, Fire and Ambulance emergency service vehicles.
  - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

This Order may be cited as Somerset County Council, Catherine Hill, Catherine Street and Whittox Lane in the Parish of Frome (Temporary Prohibition of Motor Vehicles and Suspension of One-Way Restriction) Order 2019

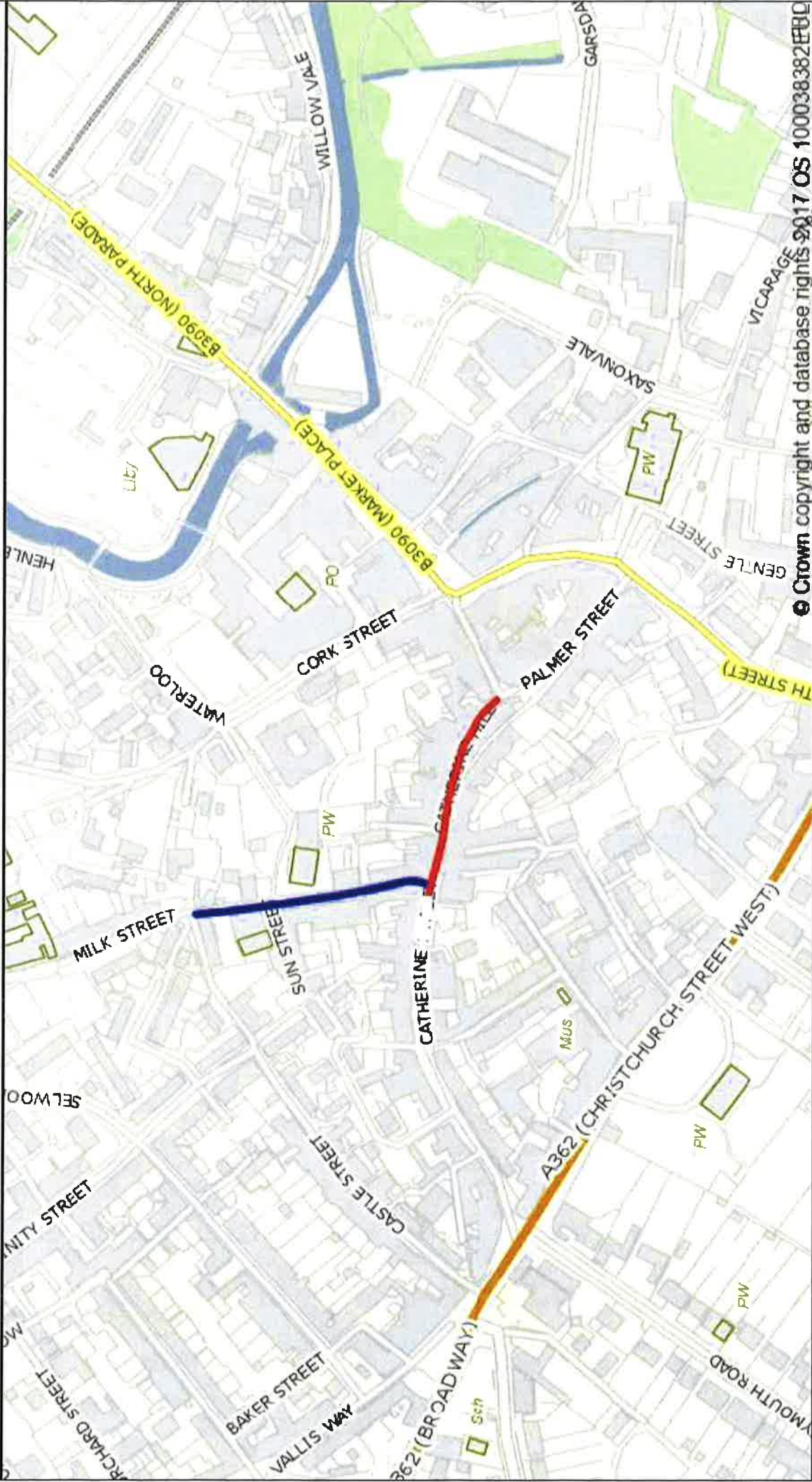
